

Chestify AI

Is making significant strides in the medical field. They are on the cusp of finalizing a partnership with Checkup Labs in Kenya to process over 6,000 medical images monthly, with a promising 80% reduction in turnaround time.

Motito

KPMG Ghana competition winner, is a financing solution that emerged from the desire to address financial barriers in Africa. Motito is committed to creating a world where every African has the opportunity to live a better life, demonstrating the potential of innovative financial technologies to make a significant difference.

BD Waste

Is redefining waste management in heavily polluted areas. Their pilot projects in three communities have shown an impressive capacity to collect 40 tons of waste per month, reducing ground rubbish by 90%.

E-Campus

An e-learning solution making significant impacts in Africa's education sector. eCampus is transforming the way learning and assessments are conducted, reaching millions and democratizing education across the continent.

The third cohort of ASIP marks a significant leap in terms of impact. The creation of 9,600 jobs is a testament to the program's contribution to economic growth. It's a clear indicator of how startups, when adequately supported, can become engines of employment and prosperity. Additionally, the emphasis on women in leadership within these startups aligns with a broader goal of inclusive growth and gender equity in business – a crucial aspect in a continent where women play a pivotal role in economic and social spheres.

ASIP is a vital contributor to the entrepreneurial land-scape in Africa with investments worth approximately 30 million dollars. Its approach, tailored to the unique challenges and opportunities of the continent, is making a significant difference in the lives of young entrepreneurs and the broader African economy. With the culmination of Cohort 4 on February 8, 2024, ASIP will have successfully nurtured 40 startups. As ASIP continues to evolve and support more startups, its role in shaping the future of Africa's digital and economic landscape becomes increasingly crucial.



This prestigious awards scheme aligns with the Africa Prosperity Agenda, recognising individuals who have made significant contributions to the continent's advancement and prosperity. Through this initiative, exceptional leaders and visionaries are acknowledged for their dedication, innovation, and impact in driving forward the continent's development.



AND THE WINNER IS...

SOCIAL INFRASTRUCTURE AWARD

DEFINITION: An individual who has impacted society at the highest level with an innovative initiative that impacts on the well-being and development of communities. It acknowledges the importance of building not just physical structures, but also fostering a supportive and inclusive social environment with sustainable practices that enhance social infrastructure.



JULIUS MWALE

Entrepreneur and Philanthropist

Julius Mwale, a visionary Kenyan entrepreneur, is a transformative force in the intersection of health, technology, and community development, justifying his recognition in the category of health.

As the founder and primary investor behind Mwale Medical and Technology City (MMTC), a groundbreaking \$2 billion sustainable metropolis in Kenya, Mwale has exemplified innovation and leadership in the healthcare sector.

Central to MMTC is the Hamptons Hospital, a testament to Mwale's commitment to accessible healthcare. Treating patients from the county, particularly those covered by the National Hospital Insurance Fund, Hamptons Hospital stands as a beacon of comprehensive medical care with a capacity to accommodate 5,000 patients.

Beyond healthcare, MMTC represents Mwale's holistic vision for community development. Mwale's strategic approach goes beyond infrastructure; he has integrated the original villagers from Lunza, his hometown, into the city, ensuring that the benefits of development are shared inclusively.

Mwale's commitment extends to uplifting communities across Africa. Through MMTC, he has already expanded into 12 African countries, demonstrating a pan-African vision for sustainable development. His goal of establishing 18 smart cities and uplifting 800 million people by 2050 reflects a profound dedication to improving lives and driving progress.

Mwale's story is even more inspiring when taking into account his humble beginnings. Prior to founding MMTC, after completing his college education, Mwale joined Kenya Airforce, where he was involved in tech research. Following an intellectual property rights dispute which left him fearing for his life, he ended up in the US, where he sought asylum and became homeless. He later enrolled at Columbia University and completed a degree in electrical engineering, after which he launched SBA Technologies, Inc, in New York.

SBA Technology invented a patent for two-factor biometric authentication, which it now offers technological security solutions to some of the biggest names in the US, including Bank of America, Bank of New York and J.P. Morgan.

YOUNG ENTREPRENEUR AWARD

DEFINITION: An individual, typically under the age of 35, who has demonstrated exceptional entrepreneurial spirit, innovation and business acumen in establishing and running a successful business. This award recognises the individual's achievements in overcoming challenges, creating a significant impact in their industry, and contributing to economic growth.



OLUWATOSIN AJIBADE AKA MR EAZI

Entrepreneur, Music Executive, Singer

Oluwatosin Oluwole Ajibade, more popularly known as Mr Eazi, is a trailblazing singer, songwriter, producer and celebrated entrepreneur. While he is probably most recognised for his award-winning global music career, through which he has pioneered his Banku music genre, as a businessman, Ajibade wears the hat of tech entrepreneur and venture capital investor.

In 2019, Ajibade founded emPawa Africa, an Africanfocused music services company working with artists, producers, and independent labels across the continent.

The company, described as a talent incubation initiative, aligns with Mr Ajibade's vision of helping new artists reach their full potential.

Through initiatives like emPawa, Ajibade is not just shaping the present but investing in the future of African music. In December 2022 Vydia, a digital audio and video distribution infrastructure company that emPawa Africa had invested in was sold for \$1 billion.

It was acquired by American firm Gamma, a music and technology firm owned by former Apple Music Executive, Larry Jackson.

Additionally, Ajibade founded investment firm

Zagadat Capital, showcasing his multifaceted approach to business. Since it's 2021 launch, the company has invested in companies such as remittance-based lending firm Paisa, Eden Life, African fintech Pawapay, Shoobs and South Africa basketball team Cape Town Tigers.


Musically, he has seamlessly woven his own lane and is renowned for pioneering Banku music, a genre characterised by percolating rhythms and laid-back vocals in Ghanaian Pidgin English.

His tunes effortlessly blend global pop, dancehall, highlife, and hip-hop and r&b. With a music catalogue amassing over four billion global streams, he has also enjoyed enviable collaborations with some of the world's biggest artists – Beyoncé, J Balvin, Bad Bunny, and Nicki Minaj. In addition, he has picked up a coveted Grammy award along the way.

The release of his long-awaited debut album The Evil Genius, an innovative project fusing contemporary African art and music, saw him host accompanying exhibitions at Gallery 1957 in Ghana, and in London during the 1-54 Contemporary African Art Fair at Somerset House.

TECHNOLOGY AND INNOVATION AWARD

DEFINITION: An individual who has made a significant contribution in the field of technology and innovation. This award recognises groundbreaking advancements or pioneering work in developing new technologies, applying existing technology in innovative ways, or significantly enhancing technological processes.



DR MARY SPIO

CEO and Founder, CEEK Virtual Reality

Dr Mary Spio, a trailblazer in technology and innovation, is a force to be reckoned with – an accomplished deep space engineer, tech innovator, entrepreneur, and author.

Currently at the helm as the CEO and founder of CEEK Virtual Reality, Dr Spio leads a platform offering immersive and social virtual reality experiences, while collaborating with global icons such as Microsoft, Coca-Cola, Billboard, and celebrities such as Sarkodie.

Her impact has earned her recognition as one of the 100 History Makers in the Making by NBC News, a New Power Generation leader by Essence Magazine, and an innovation and entrepreneurship evangelist by the U.S. Department of State. Awards such as the Yueh-Ying Hu Memorial National Award for Innovation and the Boeing Outstanding Achievement in Electrical Engineering Award underscore her groundbreaking contributions.

Armed with a Bachelor of Science degree in electrical engineering from Syracuse University and a Master of Science degree in electrical engineering and computer science from Georgia Institute of Technology, Spio's journey is marked by a relentless pursuit of excellence.

Her six-year stint in the US Air Force as a wideband and satellite communications technician laid the

foundation for a stellar career. Subsequently, she contributed significantly as a satellite communications engineer for NASA and Boeing, where she pioneered and patented groundbreaking technology for digital cinema distribution.


Spio's influence extends beyond accolades: she's an influential speaker at prestigious events like the Grace Hopper Celebration, the WomenTech Global Conference, and the Pennsylvania Conference for Women. A prolific author, she has penned two books, including the bestseller "It's Not Rocket Science: 7 Game-Changing Traits for Uncommon Success", a self-help book published in 2015, and "A Song for Carmine", a romance novel.

As a role model and visionary, Spio deserves recognition in the technology and innovation sphere for leveraging her skills to create cutting-edge solutions that enhance the lives and entertainment experiences of millions worldwide.

Dr Mary Spio is not just a leader, she is the embodiment of creativity, courage, and collaboration – an inspiration and empowerment for women, particularly women of colour, aspiring to excel in STEM fields.

FINANCIAL LEADERSHIP AWARD

DEFINITION: An individual in a senior position in financial services who has demonstrated exceptional leadership, expertise and contributions. Criteria for this accolade include sound financial management, prudent risk management and innovative financial thinking.



PROFESSOR BENEDICT ORAMAH

President and Chair of the Board of African Export-Import Bank

Professor Benedict Oramah, an esteemed Nigerian economist, currently serves as the President and Chairman of the Board of Directors of the African Export-Import Bank (Afreximbank), standing as a beacon in the world of finance. His illustrious career spans decades of commitment and expertise in international trade and finance.

As the President of Afreximbank, Professor Oramah has significantly expanded the institution's reach and enhanced its global standing. The bank actively supports the African Continental Free Trade Agreement (AfCFTA), a landmark initiative in African trade and development. Under Professor Oramah's leadership, Afreximbank has spearheaded innovative digital platforms to facilitate intra-regional trade and investments, transforming cross-border payments and enhancing access to valuable trade information. Notable platforms include the Pan-African Payment and Settlement System (PAPSS), a Trade Information Platform, and MANSA, a repository platform streamlining customer due diligence on African entities.

Professor Oramah serves as one of the key figures in the African Union's Africa Vaccine Acquisition Task Team (AVATT). In this capacity, Afreximbank, under his guidance, played a pivotal role in securing 400 million

doses of Johnson and Johnson COVID-19 vaccines for the continent. This achievement was made possible through a US\$2 billion Advanced Procurement Commitment (APC) guarantee provided by Afreximbank to the vaccine manufacturer on behalf of African countries.

Under Oramah's visionary stewardship, Afreximbank has achieved remarkable milestones, solidifying its status as a powerhouse in the industry.

Recognised as the "African Company of the Year" at the 11th All Africa Business Leaders Awards in 2023, the institution stands as a testament to Oramah's adept corporate governance and impactful leadership.

Oramah serves as the chairman or board member of various organisations, showcasing his broad influence in diverse sectors.

His contributions have been acknowledged nationally and internationally, receiving prestigious awards such as the Commander of the Order of the Niger (CON) by the Federal Government of Nigeria in 2022 and the Russian Federation's state award of the Order of Friendship in 2019

Consistently recognised as one of the 100 Most Influential Africans by New African Magazine, Oramah's achievements culminated in being named Forbes Africa Magazine's 2023 Person of The Year.

PHILANTHROPIST AWARD

DEFINITION: This award is given to an individual recognised for substantial and impactful contributions to charitable causes. Criteria for this recognition include the size of donations, impact of effort, innovative approach and leadership in encouraging others to give, as well as a consistent dedication to philanthropic work.



DR PRECIOUS MOLOI-MOTSEPE

Co-founder & CEO, Motsepe Foundation

Dr Moloi-Motsepe, alongside her husband Dr Patrice Motsepe, established the Motsepe Foundation in 1999. The Foundation aims to actively contribute to the elimination of poverty and the sustainable enhancement of living conditions for disadvantaged individuals in South Africa, across Africa, and globally.

The Foundation was founded on the philosophy of 'ubuntu', the African concept of giving and caring for your neighbour and other members of your community.

In 2013 the Motsepe family were the first on the African continent to join the Giving Pledge, started by Bill and Melinda Gates and Warren Buffet, in which they promised to give at least 50 per cent of their family wealth to charitable causes.

Being one of the most substantial philanthropic organisations in South Africa and the continent, the Motsepe Foundation has made significant donations since its inception.

In 2023, the foundation donated R30m (US\$1.5m) to 26 university student representative councils (SRCs) to be allocated towards helping students with student registration, fees and historical debt.

The Foundation also allocated 300 new bursaries for students at both universities and schools for the 2023 academic year.

Although based in South Africa, the Foundation extends its reach throughout sub-Saharan Africa and builds global partnerships across continents.

The Foundation's initiatives align with 12 out of the 17 United Nations Sustainable Development Goals (SDGs).

Born in the Soweto area of Johannesburg, Dr Moloi-Motsepe is a medical doctor, who specialised in children's and women's health.

She continues to promote health, well-being, education and economic empowerment through NGOs as well as her philanthropic work

She is also the founder and CEO of African Fashion International (AFI), a globally affiliated enterprise that champions African creatives.

In 2017 she received the prestigious Fashion 4
Development Franca Sozzani Award at the United
Nations in New York, for her efforts in promoting African
fashion designers and supporting the empowerment of
disadvantaged women along the supply chain.

AFRICA CHAMPION AWARD

DEFINITION: An accolade granted to an individual, who has shown support for the development, prosperity, and welfare of Africa. The award encompasses a variety of fields such as social progress, environmental conservation, cultural promotion, and the promotion of African values and interests.



BARONESS SCOTLAND OF ASTHAL

Secretary-General of the Commonwealth Secretariat

Patricia Scotland, Baroness Scotland of Asthal, PC, KC is a British diplomat, barrister and politician, currently serving as the sixth secretary-general of the Commonwealth of Nations. She was first elected at the 2015 Commonwealth Heads of Government Meeting and began her first of a maximum of two possible four-year terms on 1 April 2016.

Baroness Scotland was re-elected to a second term at the 2022 Commonwealth Heads of Government Meeting, as her first term had been extended by two years due to the pandemic and the postponement of the 2020 Commonwealth Heads of Government Meeting (CHOGM). She won despite opposition from the UK Government led by Prime Minister Boris Johnson. It was the backing of African governments that kept her in the position. Her allies claimed that it was Baroness Scotland's refusal to do the UK government's bidding that was behind Johnson's animosity.

Her support throughout her tenure for the so-called smaller African and Caribbean nations of the Commonwealth against the bigger ones such as the UK, Canada and Australia is believed to have been behind their show of support. This was despite the fact that the UK, Australia, New Zealand and Canada had all threatened to cut funding to the organisation.

Prior to being secretary-general of the Commonwealth, Baroness Scotland served as UK Attorney General from 28 June 2007 - 11 May 2010. She was appointed to the position by Prime Minister Gordon Brown and was the first woman to hold the office since its foundation in 1315. During her time as Attorney General, she continued to promote pro bono work by lawyers and created an international and Schools Pro Bono Committee responsible for co-ordinating pro bono work. She has also been a strong advocate for toughening the law against and helping victims of domestic violence.

Baroness Scotland was elevated to the House of Lords in 1997 and, as a British Labour Party politician, served in ministerial positions within the UK Government, most notably as the aforementioned Attorney General for England and Wales and Advocate General for Northern Ireland. She is a dual citizen of the United Kingdom and Dominica, where she was born.

In November 2012, she was appointed Prime Ministerial Trade Envoy to South Africa. In December 2014, she was elected as the Alderman for the ward of Bishopsgate in the City of London, having stood (in accordance with convention in the City) as an independent candidate.

Back in 1991, Patricia Scotland became the first black woman to be appointed a Queen's Counsel.

INDUSTRIALIST OF THE YEAR AWARD

DEFINITION: An individual who has exhibited exceptional leadership, innovation, and excellence in the field of industrial development. This award honours industrialists who have made substantial contributions to their respective industries, fostering growth, economic development, and technological advancement.

Chairman and Founder, Cleopatra Group

With a workforce of 25,000 engineers, technicians, and workers, Ceramica Cleopatra stands as an industry powerhouse. Its global footprint extends to 108 countries, reflecting its robust presence in the international market as a leading exporter of ceramics, porcelain, and sanitary ware.

Since the early 1980s Abou El Enein's business ventures have diversified to include the areas of agriculture, mining, real estate, tourism, media, high-tech projects and aviation.

A member of the Egyptian People's Assembly since 1995, since January 2021, he has held the esteemed position of Deputy Speaker of the House of Representatives.

His eponymous charitable foundation is focused on a number of core pillars: youth empowerment, health care, women empowerment and education.
